### **CALL FOR EXPRESSION OF INTEREST**

Bosnia and Herzegovina/Municipality of Stari Grad Sarajevo (hereinafter referred to as the Borrower) received a loan from the Saudi Development Fund (hereinafter referred to as the Fund) for the financing of the Project "Development of the Infrastructure for the Municipality of Stari Grad Sarajevo" (hereinafter referred to as the Project). The purpose of the Fund is to assist in the development of the economy by approving the credit resources necessary for the implementation of the Project and development program. Pursuant to the decision of the Fund no. 15/118/2251, the Borrower is granted under the terms and conditions contained in the Agreement. The tendering process will be guided by the rules and procedures of the Fund, as a nationally competitive bidding of qualified companies.

The Municipality of Stari Grad Sarajevo (hereinafter referred to as the Client) hereby invites interested companies to submit their applications for the prequalification for the following works:  
Construction and Reconstruction of the Sports Hall nearby Elementary School "Edhem Mulabdić".

The contract will cover the following construction works:

- Construction and finishing works;
- Water supply and sanitation;
- Electrical installations and
- Mechanical installations.

The contracting authority shall assign the above works in one package according to the procurement plan. The expected construction period is March 2019 to August 2021 including the Defects Liability Period. The Client hereby invites eligible construction companies (hereinafter referred to as the Contractors) to express their interest in providing the works. Interested Contractors should provide data demonstrating that they have the necessary qualifications and experience to provide the services:

- Contractor(s) Registration and Corporate Capacity;
- Documented Reference and Specific Experience of the Contractor(s) on similar assignments.

In order to determine the skills and experience of the shortlisted contractors, the information provided should include the following:

1. Organization and general experience of the company/JV: Copy of the registration and the company/JV information: name, status, address, phone number, fax number, e-mail address, year of establishment, contact person in charge of the project, number of permanent and part-time employees, area of expertise;
2. Financial stability: audited balance sheets in the last 3 (three) years that will demonstrate the financial stability of the applicant and its long-term profitability;

3. Specific experience on similar works. Information on experience on similar jobs performed in the last 3 (three) years, including value(s) and locality(ies) of the contract(s), the number of employees involved in the contract(s), the name of the client(s), the name of the partner in charge for execution of the contract, financing source(s), type of the works provided, commencement and completion dates of the contract(s), short description of the contract(s), successfully implemented minimum of two similar jobs in that last 3 (three) years of minimum value of 1,000,000 BAM each. Applicant must submit the written and signed references from the previous client(s) to prove this.
4. Available and accessible competent professionals to perform the stated works and
5. List of current contract(s) including commencement and completion dates and employed staff and construction equipment.
