CALL FOR EXPRESSION OF INTEREST

Bosnia and Herzegovina/Municipality of Stari Grad Sarajevo (hereinafter referred to as the Borrower) received a loan from the Saudi Development Fund (hereinafter referred to as the Fund) for the financing of the Project "Development of the Infrastructure for the Municipality of Stari Grad Sarajevo" (hereinafter referred to as the Project). The purpose of the Fund is to assist in the development of the economy by approving the credit resources necessary for the implementation of the Project and development program. Pursuant to the decision of the Fund no. 15/118/2251, the Borrower is granted under the terms and conditions contained in the Agreement. The tendering process will be guided by the rules and procedures of the Fund, as a nationally competitive bidding of qualified companies.

The Municipality of Stari Grad Sarajevo (hereinafter referred to as the Client) hereby invites interested companies to submit their applications for the prequalification for the following services:

Supervision of works and delivery of the energy certification report on construction, reconstruction, completion and repair of facilities in the area of Municipality of Stari Grad Sarajevo:

- Construction and Reconstruction of the Sports Hall nearby Elementary School "Edhem Mulabdić";
- Renovation of the Building of Municipality of Stari Grad Sarajevo, and
- Completion and Equipping of the Community Health Centre "Stari Grad"

Services will include supervision of the following construction works:

- Construction and finishing works,
- Water supply and sanitation,
- Electrical installations and
- Mechanical installations;

and delivery of the energy certification report for all objects that are include in project "Development of Infrastructure for the Municipality of Stari Grad Sarajevo".

The contracting authority shall assign the above services in one package according to the procurement plan.

The expected period of performance of the services is March 2019 to September 2021 including the Defects Liability Period of the Contracts for Construction Works.

The Client hereby invites eligible consultancy companies (hereinafter referred to as the Consultants) to express their interest in providing the services. Interested Consultants should provide data demonstrating that they have the necessary qualifications and experience to provide the services:

- Consultant Registration and Corporate Capacity and
- Documented Reference and Specific Experience of the Consultants on similar assignments.

Based on the information submitted, the Client will form a shortlist of six (6) best ranked candidates based on the following criteria:

- Company profile 20%
- General experience 20%
- Previous experience of the company in the specific engineering supervision of projects and delivery of the energy certification report 50%
- Experience in BiH/region 10%

In order to determine the skills and experience of the shortlisted consultants, the information provided should include the following:

1. Company information: name, registration, address, telephone number, fax, e-mail address, year of establishment, contact person for the Project, revised balance sheet for the past five (5) years, which must show the financial situation of the applicant as well long-term profitability, number of permanent staff and part-time employees with their areas of expertise.
2. Experience on similar jobs carried out in the last five (5) years including the value(s) and location(s) of the contract, the number of employees included in the contract(s), the client's name(s), the name of the partner in charge of implementing the contract, source(s) of funding, type of services provided, date of commencement and completion of the contract, short description of the contract. Proof of the above is to be followed by the signed references of the Client(s).
3. In the case of a Joint Venture application (JV), the lead partner must meet at least 65% of all qualifying criteria for financial and technical capacity while the other partners must meet at least 35%. Joint Venture (JV) must cumulatively meet the criteria for professional capacity, for which purpose the relevant value of each partner will be added to achieve the overall capacity of the consortium.
